

QWIZ Camps COVID-19 Guidelines

In accordance with our concern for the safety and well-being of all of our campers, QWIZ Camps is undertaking the following measures to prevent the transmission of COVID-19 consistent with the applicable public health guidelines. QWIZ Camps institutes the following guidelines for all 2022 camps to promote the overall safety of our campers and our staff. We require the following of all in-person QWIZ Camps campers, staffers and volunteers:

1. **PRE-CAMP: QWIZ Camps strongly encourages its campers, staff, and volunteers to be fully vaccinated and boosted against COVID-19.** All campers, staff members and volunteers at an in-person QWIZ quizbowl camp must (a) be fully vaccinated from COVID-19 no sooner than 14 calendar days prior to the start date of their camp, or (b) have tested negative for COVID-19 within 72 hours of the start date of their camp. These staff members and volunteers must also attest that they have not been in close contact with anyone who tested positive for COVID-19 in the last 14 calendar days preceding the start date of their camp, and that they themselves have not had any of the known symptoms of COVID-19 in the last 14 calendar days, as defined by current Centers for Disease Control (CDC) guidelines (e.g., fever or chills, cough, shortness of breath or difficulty breathing, fatigue, muscle or body aches, headache, new loss of taste or smell, sore throat, congestion or runny nose, nausea, or vomiting), in order to participate in an in-person QWIZ camp. All staff members and volunteers must immediately notify QWIZ Camps if exposed to COVID-19 and/or if they exhibit any symptoms of COVID-19.
2. **COVID-19 IN-CAMP SCREENING:** QWIZ Camps will make temperature checks available for all staff members, volunteers, and campers throughout its in-person camps and encourages their use on a daily basis. At a minimum, QWIZ Camps will conduct temperature checks of all staff members and volunteers every morning upon arrival to the designated camp headquarters. At a minimum, QWIZ Camps will also designate a Director, staff member, or volunteer to conduct daily temperature checks of all campers every morning and every evening during check-in for the evening competitions and/or tournaments. QWIZ Camps may designate additional temperature check periods as needed and in its sole discretion.
3. **COVID-19 ISOLATION PROCEDURES:** In the event that a staff member, volunteer, or camper records a temperature of 100.4°F or higher, or exhibits any other COVID-19 symptoms as defined by current CDC guidelines (e.g., fever or chills, cough, shortness of breath or difficulty breathing, fatigue, muscle or body aches, headache, new loss of taste or smell, sore throat, congestion or runny nose, nausea, or vomiting), they will be required to immediately isolate from others in a designated "isolation room" that will be determined at each in-person camp location during staff and volunteer orientation. QWIZ Camps will then contact the listed parent/guardian of the affected camper to arrange their departure from camp, or, in the case of an affected staff member or volunteer, QWIZ Camp will coordinate departure logistics as needed. Following the isolation of a staff member, volunteer, or camper, QWIZ Camps will pause camp activities in order to conduct temperature checks of all staff members, volunteers, and campers. QWIZ Camps will work with each in-person camp location to secure additional potential "isolation rooms" so that such space is available if multiple individuals require isolation.

4. **COVID-19 PREVENTIVE MEASURES:** QWIZ Camps requires that all staff members and volunteers observe and promote the following preventive measures at all in-person camps:
- a. Wearing of face coverings over the nose and mouth when within six feet of others and when indoors, and at all other times as required by QWIZ Camps in accordance with current CDC guidelines and the rules and regulations of the respective in-person camp locations. Exceptions may be made at the sole discretion of QWIZ Camps where accommodations are appropriate. Staff members and volunteers agree to enforce the wearing of face coverings among all campers.
 - b. Frequent hand washing and use of hand sanitizer upon entering any and all indoor facilities (including travel between classrooms, travel to and from headquarters, and to and from dining facilities).
 - c. Cleaning and disinfecting of indoor spaces including classrooms, headquarters, and residential common areas on a daily basis. Staff members and volunteers who are in charge of a classroom for either a scheduled class period, a practice session, or a competition and/or tournament, will clean and disinfect all high-touch surfaces upon the campers' exit from that room or indoor space (disinfectant wipes, spray, and hand sanitizer will be provided). For example, when a morning class period ends, the instructor in that room is responsible for disinfecting the desks and sanitizing the space (*e.g.*, entry/exit doorknobs, buzzers). For practice sessions and/or evening tournaments and/or competitions, the staffer assigned to each classroom or competition space is responsible for disinfecting the desks and sanitizing the space (*e.g.*, entry/exit doorknobs, buzzers) after each group exits the space or before the *next* group of new campers enters the space for the next practice or tournament round.
 - d. Encouraging frequent hand washing, and the use of hand sanitizer when needed, among all campers. QWIZ Camps will make hand sanitizer available to all staff members, volunteers, and campers.
 - e. Following and promoting current CDC health protocols pertaining to COVID-19 prevention at all times. Staff members and volunteers are encouraged to use their judgment when monitoring camper activities, but can contact a QWIZ Camp Director or other designated staff member as needed as issues and questions arise. Staff members and volunteers agree to notify a QWIZ Camp Director immediately or as soon as practicable if there are issues enforcing any of these preventive measures and/or if individual campers are not following these protocols or otherwise endangering the health and safety of others.
